Eur. Ing. Platonas Stylianou, New President 2024 – 2027 of the European Council of Civil Engineers



Eur. Ing. Platonas Stylianou, ECCE President 2024-2027

Eur. Ing. Platonas Stylianou has been elected as the new President of the European Council of Civil Engineers (ECCE). He took over Presidency of ECCE on 11th October 2024, during the 79th ECCE General Meeting, and will serve a three-year term from 2024 to 2027. Platonas Stylianou was previously elected ECCE Vice President and President-Elect on 23rd October 2021, during the 73rd ECCE General Meeting. Since 2014, he has represented the Cyprus Association of Civil Engineers (CYACE) as ECCE National Delegate.

PERSONAL PROFILE

Platonas Stylianou is a Chartered Civil Engineer, born in Nicosia, Cyprus in 1971. He graduated with distinction from Apostolos Petros & Pavlos Lyceum in Limassol and later pursued his studies at the Higher Technical Institute (H.T.I.). He then received a scholarship to study at the University of Glamorgan (UK), where he earned a B.Eng. (Hons) degree. He also holds postgraduate qualifications in Arbitration and Alternative Dispute Resolution (ADR).

He is a registered Civil Engineer in Cyprus since 1995 (ETEK), a Chartered Civil Engineer (CEng) in the UK, and a Fellow of the Institution of Civil Engineers (FICE). He is also a Fellow of the Chartered Institute of Arbitrators (FCIArb), a FIDIC Certified Adjudicator (FCA) and is also accredited as a mediator for trade issues.

His work focuses mainly on the following:

- Seismic analysis and Structural Design of RC Buildings.
- Seismic analysis and Structural Design of Steel/ Composite Buildings.
- Structural assessment, analysis, Consolidation and Restoration of Traditional / Listed Buildings and Monuments.
- Structural Assessment, Analysis, Design and Seismic Retrofitting of existing Buildings.
- Peer reviews of Structural Design and Due Diligence Reports.
- Structural Design of Water Retaining Structures, thanks and Silos.
- Arbitration / Adjudication / Mediation.

He was appointed on numerous projects as the principal structural designer and project coordinator, including both European and locally funded initiatives. His expertise encompasses seismic risk assessment, retrofitting of structures, and the conservation of heritage buildings. His work spans projects in Cyprus and abroad, and he actively participates in international committees, representing Cyprus in ECCE, FIB, and FIDIC.



He is a member of the central Cyprus National Technical Standardization Committee CYS TC 18: Eurocodes and Coordinator of the Subcommittee CYS TC 18 SC 03 & 04. He was appointed by FIDIC Task Group 8 (TG8) as International Expert and Friendly Reviewer for the development of the new second edition of the FIDIC Short Form of Contract (2021 Green Book).

In addition to his engineering work, is a specialist in Alternative Dispute Resolution (ADR). He is a frequent speaker on seminars for assessment and retrofitting of structures, restoration of monuments, on Arbitration, ADR and disciplinary issues and also offers expert advice on contractual matters.

He served as President of the Cyprus Association of Civil Engineers (CYACE) for two consecutive terms (2013 – 2015 and 2015 – 2017). He was a member of the ETEK Disciplinary Board from 2005 to 2014, and chairman of Division 1 from 2011 to 2014. He has been elected for the General Council of the Technical Chamber of Cyprus (ETEK) since 2014. Since 2023, he has been elected as Vice President.

The 79th ECCE General Meeting was held from 9th to 11th October 2024, in the vibrant city of Athens, Greece. The event was hosted by the Technical Chamber of Greece (TCG) and the Association of Civil Engineers of Greece (ACEG), marking a significant milestone for Greek civil engineers as it coincided with the 100th anniversary of the founding of TCG, the representative body for all qualified engineers in Greece.

Scientific Conference "Engineers' Associations: History, Roles, Interventions, and Perspectives"

As part of this centennial celebration, on 10th October 2024, TCG organized a scientific conference titled "Engineers' Associations: History, Roles, Interventions, and Perspectives" at its headquarters in Athens. The conference explored the history of engineers' organizations. their role in shaping the engineering profession, relationships with institutions their Polytechnics and technical schools, and their contributions to public discourse. The aim was to offer a broader European perspective while shedding light on the history and contributions of Technical Chamber of Greece—an institution of great significance to the country but one that remains largely unknown to the public.

The conference was moderated by ECCE Immediate Past President Aris Chatzidakis and featured presentations from several distinguished international and Greek speakers, providing valuable insights on the role of engineers' associations.

The two events, the "BIM Conference: BIM Beyond 101" and the Scientific Conference "Engineers' Associations: History, Roles, Interventions, and Perspectives," created a bridge between the past and the future. They perfectly aligned with the overarching theme and message of the new ECCE President, Platonas Stylianou: "Study and learn from the past, take action in the present to build a better future".

79th ECCE General Meeting

The 79th ECCE General Meeting focused on fostering collaboration, knowledge exchange, and addressing the challenges and opportunities within the civil engineering profession. The event brought together representatives from professional civil engineering organizations across Europe and the international community.

In his opening speech, ECCE President Dipl.-Ing. Andreas Brandner expressed gratitude to the event host s, the Technical Chamber of Greece and the Association of Civil Engineers of Greece, and acknowledged key contributors. He highlighted the importance of reflecting on the history of engineers' associations in a rapidly changing world.

Brandner addressed major challenges, such as the shortage of qualified engineers and shifting attitudes toward work-life balance. He emphasized the need for rigorous education, rejecting the idea of simplifying curricula to attract more talent, and stressed the importance of hands-on experience. He also cautioned against over-reliance on digital tools like BIM and AI, urging senior engineers to mentor younger colleagues in practical verification methods.

The President advocated for a legal framework to establish EUwide recognition of civil engineers, which would enhance professional mobility and attract talent from outside the EU. He also criticized rigid standardization processes and encouraged engineers to engage in European politics and standardization efforts. As his presidency drew to a close, he reflected on his accomplishments while acknowledging the goals that remain unmet.

Ms. Liana Anagnostaki, Director of Public Relations, International & European Affairs at the Technical Chamber of Greece (TCG), provided a detailed presentation on the TCG. Established in 1923, the TCG is a public law institution headquartered in Athens, with branches across 17 regions. It represents all qualified engineers in Greece, providing personalized services such as counseling, support, and professional development. The TCG also serves as an official consultant to the Greek government, offering expertise on technical and legislative matters and overseeing key projects like the Unified Digital Map of Greece and the digitization of building service files. The TCG's centennial celebrations, attended by the President and Prime Minister of Greece, highlighted its role in shaping the nation's built environment under the theme "100 years of shaping the Greece of Tomorrow – and we continue."

Association of Civil Engineers of Greece Vice President Paris Charlafits welcomed attendees, emphasizing Athens' historical significance as the cradle of democracy and innovation. He encouraged participants to draw inspiration from both the city's architectural heritage and its tradition of learning. Charlafits called for sustainable development,

infrastructure advancement, and the integration of technology, urging a spirit of collaboration and ideasharing to shape the future of civil engineering.

The meeting, conducted in a hybrid format with over 35 national delegates in attendance, featured several key updates. These included the presentation of the ECCE
Activity Report since May 2024, updates from the construction industry, and the discussion on ECCE financial issues and management led by Vice President/Treasurer Helena Endriksone.

Upcoming ECCE General Meetings in 2025 were also discussed. The 80th ECCE General Meeting will be held from 20th to 21st March 2025, in the island of Madeira, in Portugal, hosted by the Ordem dos Engenheiros, and the 81st ECCE General Meeting will be held in the autumn 2025, in Split, in Croatia, hosted by the Croatian Chamber of Civil Engineers.

One of the highlights was the progress report on the <u>ECCE initiative to update the book Civil Engineering Profession in Europe</u>, led by Vice President/President Elect Platonas Stylianou. The project, which involves reorganizing and expanding the 2005 edition, aims to create an online database and a digital version of the book. All the nine chapters' surveys have been completed, with the full project expected to be finalized by the second quarter of 2025.

A proposal for an ECCE position paper on Building Information Modelling (BIM) was also put forward by Jeanette Muñoz Abela of the Kamra tal-Periti, Malta.

As Brandner's term concluded, he reflected on his presidency, noting the challenges posed by the pandemic but expressing pride in advancing goals like professional development and cross-border collaboration. He encouraged his successor, Platonas Stylianou, to focus on increasing diversity in leadership, particularly by involving more women and young people.

Stylianou, in his opening address as ECCE President, expressed pride and gratitude, emphasizing the importance of unity in addressing challenges like climate change and sustainable development. He called for innovation, the use of modern technologies, and ongoing education to meet future demands. Stylianou stressed the need for collective effort and cooperation, particularly on initiatives related to the Green Deal, Climate Change, and Construction 2050.

As part of the hospitality program organized by the Technical Chamber of Greece, attendees enjoyed traditional Greek cuisine with views of the

Parthenon and participated in a technical visit to the Ellinikon Experience Park.
